

# WHAT DOES THE FUND INVEST IN?

The Fund's objective is to provide long-term capital growth and income with moderate risk. The Fund uses an asset allocation approach. It invests primarily in a diversified mix of funds and ETFs that provide exposure to global equity and fixed-income securities.

#### **HOW RISKY IS IT?**

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk ratina

AGF Investments Inc. has rated the volatility of this Fund as low to medium.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### **HOW HAS THE FUND PERFORMED?**

This section tells you how Series F units of the Fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

# Year-by-year returns

This chart shows how Series F units of the Fund have performed in each of the past 10 years. The Fund dropped in value in 2 of the last 10 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for Series F units of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

# Average return

The annual compounded return of Series F units of the Fund was 5.4% over the past 10 years. If you had invested \$1,000 in the Fund 10 years ago, your investment would now be worth \$1,694.

Effective June 30, 2023, the Fund's investment objective was changed to reflect the Fund's focus on an asset allocation strategy, including offering the portfolio manager increased flexibility to invest in underlying funds and ETFs that provide exposure to global equity and fixed-income securities. Performance prior to this date would have been different had the current objective been in effect.



#### WHO IS THIS FUND FOR?

- you want a managed portfolio of equity and fixed-income securities in a single fund
- you are an income-oriented investor, investing for the medium to long term
- you tolerate low to medium risk

#### A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, generally, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

# **HOW MUCH DOES IT COST?**

The following tables show the fees and expenses you could pay to buy, own and sell Series F units of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

# 1. Sales charges

No sales charges are applicable for this series of the Fund. You can buy Series F units only through representatives who have received prior approval from AGF Investments Inc.

#### 2. Fund expenses

You do not pay these expenses directly. They affect you because they reduce the Fund's return. As of September 30, 2023, the series' expenses were 1.31% of its value. This equals \$13.10 for every \$1,000 invested.

Management expense ratio (MER) This is the total of the Fund's management fee, fixed administration fee, any operating expenses not covered by the fixed administration fee, and the Fund's proportionate share of the MER, if applicable, of any underlying fund(s). AGF Investments Inc. waived some or all of the Fund's expenses. If it had not done so, the MER would have been higher.	1.22%

# 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Fund.

Fee	What you pay
Short-term or frequent trading fee	Up to 2% of the value of securities you sell or switch within 30 calendar days of purchase, or whether there have been multiple redemptions or switches made within 15 calendar days of purchase. These fees go to the Fund.
Fee-for-service fee	This series is available to you if you have a fee-based or wrap account for which you may pay a fee directly to your representative's firm.

#### WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
