

## AGF Elements Global Portfolio Class – Mutual Fund Series

This document contains key information you should know about AGF Elements Global Portfolio Class. You can find more detailed information in the fund's simplified prospectus. **Before you invest in any fund, you should consider how the fund would work with your other investments and your tolerance for risk.**

**Effective as of July 5, 2023, all series of the Fund will be closed to new investors. The Fund will remain available to existing investors, including those with systematic investment plans.**

**Effective June 1, 2022, you are no longer able to purchase securities of the fund under the deferred sales charge (DSC) option or low load option. If you acquired securities of the fund under the DSC option or low load option prior to June 1, 2022, your redemption schedule continues to apply as described. Switches between AGF funds within the same sales charge option are still available.**

### WHAT DOES THE FUND INVEST IN?

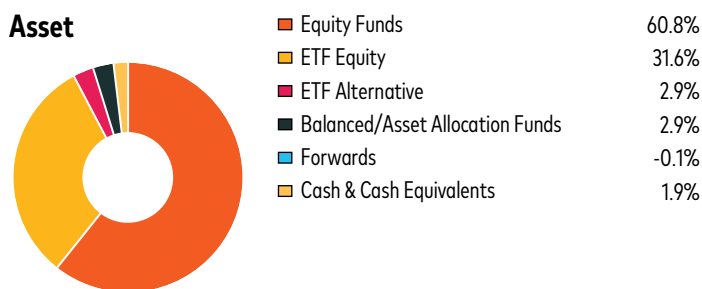
The portfolio class' objective is to provide superior long-term returns by investing primarily in equity mutual funds from around the globe.

## HOW RISKY IS IT?

The value of the fund can go down as well as up. You could lose money.

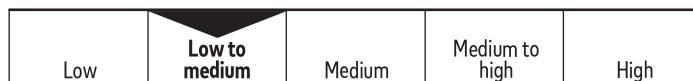
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

AGF Investments Inc. has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

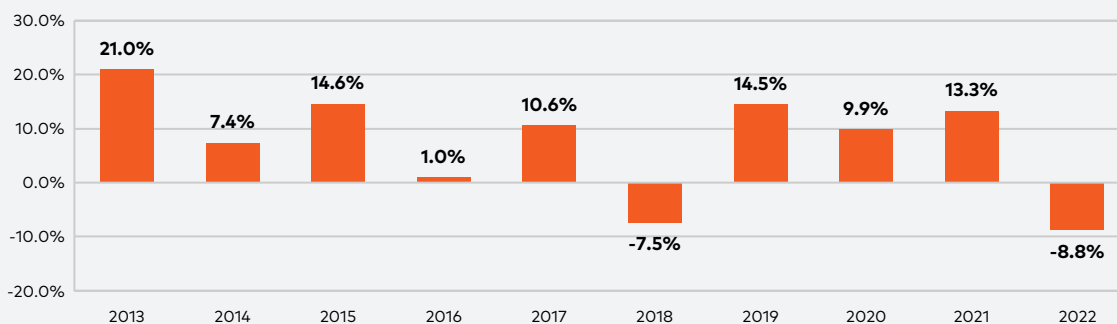
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

## HOW HAS THE FUND PERFORMED?

This section tells you how Mutual Fund Series shares of the fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

### Year-by-year returns

This chart shows how Mutual Fund Series shares of the fund have performed in each of the past 10 years. The fund dropped in value in 2 of the last 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Mutual Fund Series shares of the fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

The annual compounded return of Mutual Fund Series shares of the fund was 7.1% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would now be worth \$1,977.

**Effective April 17, 2014, the fund's investment objective was changed to provide superior long-term returns by investing primarily in equity mutual funds from around the globe. Performance prior to this date would have been different had the current objective been in effect.**

## WHO IS THIS FUND FOR?

- you want a globally diversified mix of equity funds in a single portfolio
- you are investing for the longer term
- you tolerate low to medium risk
- you are investing in a non-registered account and want to invest in a fund within a corporate class structure that may have loss carryforwards that may enable tax-deferred growth

## A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, generally, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Mutual Fund Series shares of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You have to choose a sales charge option when you buy the fund. Ask about the pros and cons of each option.

## HOW MUCH DOES IT COST? CONT'D

### 2. Fund expenses

You do not pay these expenses directly. They affect you because they reduce the fund's return. As of September 30, 2022, the series' expenses were 2.97% of its value. This equals \$29.70 for every \$1,000 invested.

	Annual rate (as a % of the fund's value)
<b>Management expense ratio (MER)</b> This is the total of the fund's management fee (which includes the trailing commission), fixed administration fee, any operating expenses not covered by the fixed administration fee, and the fund's proportionate share of the MER, if applicable, of any underlying fund(s). AGF Investments Inc. waived some or all of the fund's expenses. If it had not done so, the MER would have been higher.	2.87%

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and/or advice that your representative and their firm provide to you.

AGF Investments Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

Sales charge option	Amount of trailing commission
<b>Front end sales charge</b>	up to 1.25% (\$12.50 for every \$1,000 invested) of the value of your investment each year.
<b>Deferred sales charge</b>	up to 0.50% (\$5.00 for every \$1,000 invested) of the value of your investment for the first 7 years, and up to 1.25% (\$12.50 for every \$1,000 invested) every year thereafter.
<b>Low Load sales charge</b>	up to 0.50% (\$5.00 for every \$1,000 invested) of the value of your investment for the first 3 years, and up to 1.25% (\$12.50 for every \$1,000 invested) every year thereafter.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Short-term or frequent trading fee</b>	Up to 2% of the value of securities you sell or switch within 30 calendar days of purchase, or whether there have been multiple redemptions or switches made within 15 calendar days of purchase. These fees go to the fund.
<b>Switch fee</b>	Your registered representative may charge you up to 2% of the value of securities you switch to another AGF fund.

## WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
