**ANNUAL MEETING OF SHAREHOLDERS OF:
AGF ALL WORLD TAX ADVANTAGE GROUP
LIMITED (“AWTAG”)**

**SPECIAL MEETING OF UNITHOLDERS OF:
AGF STRATEGIC INCOME FUND
(the “Trust Fund”)**

This is notice that the annual meeting of the shareholders of AWTAG and the special meeting of unitholders of the Trust Fund will be held at **11:00 a.m.** (Eastern time) on Thursday, June 15, 2023, solely as virtual (online) meetings by way of live audio webcast (including any adjournment or postponement thereof, each, a “**Meeting**”, and collectively, the “**Meetings**”). Shareholders of AWTAG and unitholders of the Trust Fund are referred to as “securityholders”.

The Meetings will be held for the following purpose(s):

1. Annual Meeting of AWTAG to (i) elect directors for the ensuing year, and (ii) appoint the auditor for the ensuing year and authorize the directors to fix the remuneration of the auditor. See “*Annual Meeting Matters of AWTAG*” in the Management Information Circular (the “**Circular**”).
2. Special Meeting of the Trust Fund to pass a resolution to change the investment objective of the Trust Fund to the following: “The Fund’s objective is to provide long-term capital growth and income with moderate risk. The Fund uses an asset allocation approach. It invests primarily in a diversified mix of funds and ETFs that provide exposure to global equity and fixed-income securities.” See “*Special Meeting Matter – Investment Objective Change*” in the Circular.

The Meetings shall also transact such other business as may properly come before the Meetings. Please review the Circular before voting.

AGF Investments Inc. (“**AGF**”), as manager of the corporate classes of AWTAG and the Trust Fund, is holding the Meetings solely as virtual (online) meetings which will be conducted by way of live audio webcast. All securityholders, regardless of geographic location, will have an equal opportunity to participate at the Meetings and engage with the manager in real time.

Participants will need an Internet connected device such as a computer, tablet or cellphone in order to access the virtual Meetings platform. The virtual Meetings platform will be fully supported across popular web browsers and devices running the most current version of applicable software plugins. Securityholders participating in the Meetings must remain connected to the Internet at all times during the Meetings in order to vote when balloting commences. It is a securityholder’s responsibility to ensure Internet connectivity for the duration of the Meetings. **Even if you plan to join the Meetings, you should consider voting in advance so that your vote will be counted in the event you experience any technical difficulties during the Meetings.**

ATTENDING VIRTUAL MEETINGS

Registered securityholders and duly appointed proxyholders may attend and vote online at the Meetings by visiting www.virtualshareholdermeeting.com/AGF2023 (the “**Meetings Website**”) and entering the 16-digit control number found on the proxy form or voting instruction form, as applicable. Participants will require an Internet connected device such as a computer, tablet or cellphone in order to access the Meetings Website. The Meetings Website is fully supported across browsers and devices running the most updated version of applicable software plug-ins. Ensure that you have a strong, preferably high-speed, internet connection to participate in the Meetings.

The Meetings will begin promptly at 11 a.m. Eastern Time on June 15, 2023. Online check-in will begin 15 minutes prior to the Meetings. Please allow ample time for online check-in procedures. If you encounter any difficulties accessing the Meetings, you may call the technical support number that will be posted on the login page of the Meetings.

Registered securityholders and duly appointed proxyholders who attend the Meetings will be able to participate in the live webcast in real time, submit questions and vote during the course of the Meetings. Non-registered (beneficial) securityholders who have not duly appointed themselves as proxyholder may attend the live webcast of the Meetings and submit questions by joining online at the Meetings Website; however, such individuals will not be able to vote at the Meetings. Guests may also attend the live webcast but will not be able to submit questions or vote.

NOTICE-AND-ACCESS

Pursuant to exemptive relief, we have opted to use the notice-and-access procedure for sending proxy-related materials to securityholders for the Meetings. The notice-and-access procedure is an alternative method of delivery that is more environmentally friendly as it reduces the volume of paper and reduces the costs of printing and mailing such materials to securityholders. Instead of receiving a printed copy of the Circular with the enclosed form of proxy or voting instruction form, you are receiving this notice outlining the procedures for accessing the Circular online or requesting a paper or electronic copy

WEBSITES WHERE MEETING MATERIALS ARE POSTED

An electronic version of the Circular is available online at www.sedar.com and at www.AGF.com (please navigate to “Resources”, then “Regulatory Documents”, and then the “Securityholder Meeting Material” tab). The materials will remain available on our website for one year after the date of this notice.

VOTING

You may vote your securities by mail, telephone, online, or by attending and voting at the virtual Meetings. Please refer to the directions on your form of proxy or voting instruction form for instructions on how to vote using these methods. Each securityholder of record of AWTAG and the Trust Fund as of April 24, 2023 will be entitled to vote.

Beneficial (unregistered) securityholders (“**Non-Registered Holders**”) who wish to attend and vote at the Meetings should appoint themselves as proxyholder by following the instructions found on their voting instruction form. Only registered securityholders or duly appointed proxyholders (including Non-Registered Holders who have appointed themselves as proxyholder) may vote at the Meetings. See “Attending Virtual Meeting” above for further information on how to participate in the Meetings. Registered securityholders and duly appointed proxyholders should note that voting at the Meetings will revoke any previously submitted proxy.

Securityholders who are entitled to vote, but are unable to attend the Meetings virtually, are requested to exercise their right to vote as follows:

- **Voting by Mail** – Your completed, signed and dated form of proxy or voting instruction form, as applicable, may be delivered or mailed to Broadridge Investor Communications Corporation, at Data Processing Centre, P.O. Box 3700 STN Industrial Park, Markham, ON, L3R 9Z9.
- **Voting by Telephone (Canada and U.S. only)** – You may enter voting instructions by telephone at 1-800-474-7493 (English) or 1-800-474-7501 (French). You will be prompted to provide the 16-digit control number located next to the name of the fund on your form of proxy or voting instruction form.
- **Voting by Internet** – You may vote via the Internet at www.proxyvote.com and follow the instructions provided on the screen. You will require the 16-digit control number located next to the name of the fund on your form of proxy or voting instruction form.

In order to be valid and acted upon at the Meetings, a properly completed form of proxy or your voting instructions must be received by Broadridge Investor Communications Corporation at least 48 hours (excluding weekends and holidays) prior to the commencement of the Meetings or any adjournments or postponements thereof (the “**Proxy Voting Deadline**”).

RECOMMENDATION

AGF, as manager of the corporate classes of AWTAG and the Trust Fund, recommends that securityholders vote FOR (i) the election of the nominee directors to the board of directors of AWTAG; (ii) the appointment of the auditors and the board of directors to fix the remuneration of the auditors for AWTAG; and (iii) the change in investment objective of the Trust Fund, as applicable.

HOW TO OBTAIN A PAPER COPY OF THE MEETING MATERIALS

The paper copy of the Circular will be sent to you within three business days of receipt of your request. If we receive your request less than three business days before the Proxy Voting Deadline but before the date of the Meetings (or any adjournment or postponement), you may not receive the materials prior to the Proxy Voting Deadline.

You can also request a copy of the Circular after the date of the Meetings and for a period of one year from the date the Circular is filed on www.sedar.com, in which case, we will send it to you within 10 calendar days after receiving your request.
